**LLM Masters Degree Program** consist of 4 Semesters and a 2 Months Internee Training and Total GEPEA Credits will be determined after successful completion of the course.

**Eligibility for admission:** LLB/LLB Honors Passed from any accredited College/University, or for Administrative officers in Law & Justice from any Government or NGO/ non Govt. sectors then 1.5 years' study required to pursue LLM with GEPEA, **Medium of Instruction:** English Language.

**Mode of study:** Distance Learning/Online and Practical (Internee).

**Objective of LLM Masters of Law Program, Why LLM degree?** LLM is a postgraduate degree in law. Master of Law or LLM course offered at GEPEA University is of one-year full time study or 1.50 years' part time duration. **Exemptions Policy: 1 Subject is equal to 4 GEPEA Credits.**

If you previously studied any compatible courses/subjects mentioned in the LLM syllabus, then you may be eligible for the Course/Credits exemptions for which you have to apply for Course exemption after admission. Also, due to age bar/adult education for the Managers/Senior Executives/Supervisors/Business Entrepreneurs who wish to pursue their higher studies in Law & Justice through Distance Learning (Self Studies), for themselves GEPEA Admission Board for International Students Affairs may grant a maximum 40 Credit points as course exemptions, after that, following 80 credits s/he should be completed within stipulated time frame or maximum period of 1.5 (One & half) years.
